35th ANNUAL REPORT

Honourable Members,

I am, on behalf of the Executive Committee of the Association, pleased to extend warm welcome and greetings to all of you to the 35th Annual General Meeting of our Association. It's a great pleasure to present before you this Annual Report covering various developments mainly during the financial year 2024-25, and also cover important developments up to March 2025.

1. Last Annual General Meeting- Synopsis:

Our 34rd Annual General Meeting was held on Saturday, 11th January 2025, at Sharadashram Vidya Mandir, Bhawani Shankar Road, Dadar (West) Mumbai - 400 028. The meeting was as usual successful and attended by 142 members. For the several years AGMs were held at Mumbai. We have received requests from members to hold the AGM outside Mumbai, hence, it was decided to hold the 35th AGM at Pune, so that the members residing in Pune and nearby areas can attend the meeting. In future we will arrange AGM at other centres also.

The President, Mr. Martis, welcomed the members on his behalf and on behalf of the Executive Committee. He further informed that due to some previous engagements, Mr. S. C. Jain, General Secretary of our FOBOIRA and AIBRF, and Shri Rajesh Ingle Chief General Manager of the Bank though, invited, could not attend the meeting. He further informed that Mr. Peter Fernandes, earlier General Secretary of Bank of India Officers Association and also President of AIBOC, was invited as Chief Guest and he has graciously accepted the same. He welcomed Mr. Peter Fernandes with a bouquet of flowers.

Afterwards Mr. Martis requested the members present, to pay homage to the members and the dignitaries at the National Level, to name a prominent personality, Dr. Manmohan Singh, Ex-Prime Minister of India, who had departed for the heavenly abode during the last year, and observe two minutes silence. The members present observed a silence for two minutes in response of the appeal of the President.

Our Chief Guest Mr. Peter Fernanades delivered the speech and apprise about issues of the Retirees. Since, Mr. S. C. Jain could not attend the meeting, he sends the message conveying best wishes for the AGM. The message was read by Mr. Rajendra Master which was about appraising the general issues of retirees at industry level and bank level in particular.

After reading the message of Mr. S. C. Jain by Mr. Master, the Gen. Secretary proposed regular business and the Secretary's Report for approval of the meeting, then Treasurer proposed for Annual Accounts & Audit. All these were approved in the meeting unanimously.

The Joint General Secretary, Shri Bhaskar Bhave proposed a vote of thanks on behalf of the Association. The meeting concluded with the National anthem followed by a delicious lunch.

2. Our Unit, Our Strength Our Members Our membership reached at **6575** as on 22nd September 2025. This success is the fruitful result of the sincere efforts of the Executive Committee members and the team of activists at Mumbai, Pune, Nashik, Nagpur, Solapur, Kolhapur, Ratnagiri and other places. We will achieve the figure of 7000 membership shortly. Our Committee Members are making all out efforts to approach the Retirees at the branches and Training College during pre-retirement training sessions. We send

the introduction letters and membership forms to the retirees, elaborating the background of our activities, achievements in last 34 years appealing them to join the retirees' movement as a Life member of the organisation. We requested our old colleagues for mobilising of membership and they responded positively. We also keep our members informed through WhatsApp messages and SMS/emails, etc. The Association has introduced Google Form for enrolment of membership through link:- https://forms.gle/LUVFYA9dd5KimeD28. We also introduced QR Code to receive the payments safely and quickly. This a step towards the digitization.

Family Pensioners: Due to our efforts and regular follow up, Bank has streamlined the process of Family Pension application online through HRMS. The Bank has already issued IOM No. HO/TBD/Pension/2025-26/30 dated 6.5.2025 and same was circulated to the members on 13th May 2025. We appreciate the support from the Terminal Benefit Dept. The Executive Committee in the year 2021 decided to admit spouse of the deceased member as a life member by default and also offer the life membership to the spouse of non-members by paying nominal life membership fee of Rs. 500/-.

5. Organising Committee:

We have since reviewed our organizing committee to 19 active members, representing the specific area who take active interest in the affairs of our Association with enthusiasm and support the committee. We call these Members to attend E.C meetings as observer and trained them and subsequently elevate them to executive Committee. The list of Organising Committee members and their contacts are noted in the table Page No. 1 of the report.

6. Meetings with Members at various places:

The membership of our unit is spread over the state of Maharashtra and Goa. We therefore regularly arranged meetings at different centres like Pune, Nagpur, Thane, Panjim (Goa) and Nashik with the help of local activists. A good number of retirees are attending such meetings, and we interact with them on their issues and suggestions. Generally, our Bank's management makes available the hall or rooms in central area of city. In case such arrangement is not possible private hall is taken on rent. These meetings also solve the local problems, over and above the members get knowledge of latest developments.

Our EC Members at Pune are conducting monthly meetings for last 15 years. At Dombivli such meetings are conducted for last 10 years and at Thane for last 10 years. We have plans to arrange meetings at centres like Dadar, Andheri, Borivali, Mulund, Navi Mumbai, Ratnagiri, Raigad, Sawant wadi and Panaji. In western Maharashtra we conducted meetings at Satara, Sangili, Kolhapur & Belgaum recently.

9. Financial Position and Accounts.

Main income of our unit is lifetime membership fee of Rs. 1,250 per member and Rs. 500/- from the Family Pensioners whose spouse are not the member of the Association. Out of this collection 75% amount is transferred to 'LIFE MEMBERSHIP FUNDA/C' AND invested in Bank's Term Deposits. The remaining 25% part of this income and the amount of regular interest is available for our yearly expenses. As we have experienced that gap is met with the contribution from members from time to time. We appeal our members to contribute for specific purpose like Building Fund, Struggle fund, Contribution for Legal expenses. Recently we appeal for voluntary contribution from the members who have received EX-gratia arrears. The response from the members was spontaneous and very positive. We collected amount to the tune of Rs. 15 lacs out of which we remitted Rs. 1.50 lacs to the FOBOIRA as per their appeal. However, there are few members who are yet to remit the contribution. We appeal them please send your contribution.

At the AGM, we collect nominal contribution of Rs.100/- towards expenses of meeting. Present membership on 31th November 2025 is 6575 and our investment in Fixed Deposits is Rs. 92 Lacs.

All accounts are balanced monthly and expenses approved in the EC Committee regularly. Annual accounts are audited and tax returns filed regularly and digitally recorded.

10. Group Medical Insurance. Health Management: The Group Medical Insurance Policy for Retirees was introduced since 2015, this year the policy was renewed from 1st November 2025. It is always advisable to opt without Domiciliary policy. Our Unit assist members to renew the GMIS application online at Andheri, Thane, Pune & Nasik. We have appealed The Central Labour Commissioner that the premium for employees and retirees should be at par as per the bipartite settlement. For last several years the premium for retirees

was high comparing to employees. Due to our fight and constant fellow up, this year the premium for base policy for retires and employees is same. However, the premium for Top Up policy is very high comparing to the employees. We are trying to reduce the Top Up Policy premium to match with the employees. This year the Super Top Up Policy of SBI General Insurance Co. Ltd. is offered by K M Dastur Reinsurance Pvt Ltd. We are going to arrange meetings with K M Dastur Reinsurance Pvt Ltd at various centres for informing the members the salient features of policy and also collection of the application forms.

11. Financial Assistance - REMAS: This is a unique scheme for the welfare of Bank of India Retirees. The scheme was initiated by the contribution from the retirees and allocation from welfare fund. The members of the scheme are eligible for reimbursement either of Hospitalisation Expenses or Insurance Premium (Self Rs.5000/- & Spouse R.5000/- Total Rs.10000/ for Single Rs.5000/-) to the extent of Rs.1.50 Lakhs during the life-time. The amount is directly credited to the pension account of the member availing IBA GMIS policy. Others have to claim the reimbursement by submitting application alongwith the proof of premium payment receipt to respective the Pension paying Branch. Before introduction of GMIS Policy, the members exercised Hospitalisation expenses reimbursement option. Now they could not avail the Premium reimbursement option, hence, we have requested the REMAS Committee to enable the members to change the option from hospitalisation expenses to Reimbursement of the Premium. Members who have opted for Hospitalisation will be eligible for reimbursement of Rs. 3000/-p.a. in the month of February. The amount is credited to their Pension account.

Some of the REMAS members have exhausted the maximum limit of Rs. 1.50 lacs, and recovery is made by the banks in such cases for the excess reimbursement. We have already taken up this issue with the Bank Management and requested to raise the limit from Rs. 1.50 lacs to Rs. 2.50 lacs.

12. <u>Life Certificate</u>: All the pensioners have to submit Life Certificate every year in the month of November. The pensioner can submit the application to their Pension Paying Branch or the nearest Branch at their convenience. One has also the option of submitting the Life Certificate digitally through Jeevan Praman portal of Government of India (https://jeevanpramaan.gov.in). Please refer Head Office IOM Ref. No. HO/TBD/PEN/2024-25/243 which is circulated to the members.

Our bank has introduced the free Doorstep Banking Services for submission of the Life Certificate & any other 2 free services per month to the Pensioners. You may download the DSB App from Play Store. (Cir. No. HO/GOD/DJ/2024-25/14 dated 17.10.2024).

13. Federation (FOBOIRA) and AIBRF

The Federation of Bank of India Retirees' Associations (FOBOIRA) is one of the oldest Retiree Organisation working for last 25 Years since 1998 and is successfully assisting about 17000 retirees from 15 Units of 11 states. Our Maharashtra & Goa Unit with membership of 6575, is one of the biggest and strongest unit. Our participation is always appreciated by Federation. Meetings of Central Committee are arranged with Head Office to formulate a strategy and to resolve issues concerning the members. Some of the issues are settled at Zonal Offices. It is to be mentioned that we have cordial relations with the officials at Head Office and Zonal Office.

A. Meetings with Bank Management at HO

The meetings are scheduled as per IBA guidelines once in half year with the Chief General Manager, GM, DGM, AGM (HRD) and AGM (TBD). As per the Federation constitution The President, General Secretary, designated Organising Secretary attend the meetings with the General Secretary of the local Unit. Currently our Federation President Shri Frederick Martis and General Secretary Shri S. C. Jain, General Secretary of Maharashtra unit attend the meetings. Minutes of the meetings are sent to us duly approved by the GM, HR. We appreciate the steps taken by the Bank management for attending important issues of retirees.

B. United Efforts for Common Cause at National Front.

ALL INDIA BANK RETIREES' FEDERATION (AIBRF):

AIBRF is one of the oldest organisation, registered under Labour Law and one of the largest organisation, a national level apex body of bank retirees. The total membership of AIBRF is approximate 2,75,000 retirees of 44 affiliate Banks. Our Federation of Bank of India Retirees Associations is affiliated to AIBRF.

AIBRF recently organised demonstrations at PAN India on following issues:

- Updation of Pension
- Improvement in health insurance with waiver of GST on insurance premium
- Pension to reckoned on Special Allowance
- Direct dialogue with IBA with Retirees Organisation
- To adopt L1 procedure for the IBA Super Top Up policy

14. State committee of AIBRF - Maharashtra

AIBRF, with a view to communicate at grass root level members have extended organisational hand as State level body consisting of various regional level representatives of all Banks. State committees are working as extended arm of AIBRF. Our Unit have nominated ten representatives for various posts. The latest meeting of committee was held on 07.11.2024.

15. Achievements:

- Arrears on account of 1616-1684 Index: As per Supreme Court judgement who retired between 1.4.1998 to 30.4.2005, arrears were paid with retrospective effect with interest is achieved.
- Second Option of Pension to Compulsorily Retired Employees.
- Notional Benefit of 5-years' Service for Fixation of Basic Pension to Specialist Officers.
- ❖ 100% DA neutralisation demand is achieved.
- Group Medical Insurance Scheme for Retirees: Uniform premium for employees and retirees on base policy is achieved.
- On industry level Government and RBI Pensioners get 30% of basic pay as family pension as against Bank was getting only 15% which is improved in line with RBI & Government employees i.e. 30% without any capping.
- Long pending demand of Pension to resignees also achieved.
- Ex-gratia as interim relief to pensioners & family pensioners from November 2022

Comrades, we always stay most positive during our struggle. It is a continuous process till we achieve the same. For our main demand of pension updation, we have waited long enough. As a Senior Citizen, we hope that our legitimate demand will be accepted. We have to put our efforts to achieve our reasonable and justified demands. We call upon our Comrades to participate in all Action Programs in full strength and with firm determination and to march towards achieving our goal with a thundering **SUCCESS.**

16. Tie up with Various Hospitals and Diagnostic Centres.

Bank of India Retirees' Association has entered into Tie-Up arrangement with various Hospitals and Diagnostic Centres. Though Bank of India Retirees Association have entered into the Tie-Up arrangement, it covers ALL Bank of India Retirees and their Spouse, whether they are members or non-members and irrespective of any Retirees Association.

A] Dr. Agarwal's Eye Hospital
