	be advised to observe 12 hour fasting, take usual medication on			
	previous day and before coming to the hospital for EHC.			
	Clarification of query, if any, of the member will be replied.			
4. Day of EHC	Patient to report at Registration and Billing Counter on the 1 st floor			
,	of the Hospital at 7.30 a.m. and pay Registration fee of Rs.5000/-			
	either in Cash or by Credit/Debit Card. No cheques will be			
	accepted. Patient will be taken for EHC only after Registration and			
	Payment of Charges. EHC is expected to complete by 1 p.m.			
	While Breakfast will be provided by the Hospital as a part of the			
	package, Lunch will be provided only if EHC exceeds 2 p.m.

5. Report Collection and	Hard Copies of the Reports will be available after 3 working days			
Consultation	from EHC. Those patients who desire to consult the			
	Physician/Consultant at the Hospital need to collect the report			
	from the Hospital. Alternatively, reports will be
